The Burwood Beach Wastewater Treatment Works (WWTW) treats 48 megalitres per day and handles the wastewater for a population of up to 220,000 people.

Designed to operate at a very high rate, The Burwood Beach Wastewater Treatment Works provides secondary treatment of wastewater by the following process:



- Removal of solids
- Decrease in pathogen content, oil and grease in the wastewater
- Receives UV disinfection before being discharged to the Pacific Ocean through a 1.5 kilometre ocean outfall.

Dr David Meredith, Head of Health Services at Coal Services Pty Limited
